NOTICE OF THIRD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND RESERVATIONS FOR HOMESTAKE CABIN LOT SALES IN SPEARFISH CANYON

NOTICE IS HEREBY GIVEN that the Third Amendment to the Declaration of Covenants, Conditions, Restrictions and Reservations for Homestake Cabin Lot Sales in Spearfish Canyon has been approved by more than 2/3 of the owners of such cabin lots, present and voting or voting by mail, to the adoption of the following Amendments:

1. Amend Article III, Section 1 (b) of the Covenants in its entirety as follows:

(b) <u>Rental Use</u>. No Lot or Dwelling Unit shall be rented to non-family members for more than 14 days during any calendar year. Owners are obligated to insure compliance by Renters with this Declaration and all Spearfish Canyon rules.

2. Amend Article III, Section 1 (1) of the Covenants as follows:

(l) Restrictions on Further Subdivision, Property Restrictions, and Rezoning. No Lot shall be further subdivided or separated into smaller Lots by any Owner, and no portion less than all of any such Lot, nor any easement or other interest therein, shall be conveyed or transferred by any Owner. This provision shall not, in any way, limit Declarant from subdividing or separating into Lots any property at any time owned by Declarant and which has not previously been platted or subdivided into Lots. No further covenants, conditions, restrictions, or easements shall be recorded by the Owner, Lessee, or other person against any Lot without the provisions thereof having been first approved in writing by the Board and any covenants, conditions, restrictions, or easements recorded without such approval being evidenced thereon shall be null and void. No application for rezoning of any Lot and no applications for variances or use permits, shall be filed with any governmental authority.
